MEMORANDUM OF AGREEMENT made this 25th day of February 1973, between ACE BOOKS INC., 1120 Avenue of the Americas, New York, N.Y. 10036 U.S.A. (hereinafter called the Proprietors) and Condor Print & Verlag GMBH & Co. Frankfurt/Main, German (hereinafter called the Publishers).

WHEREBY it is mutually agreed by the parties as follows respecting the work at present entitled:

THE SIOUX SPACEMAN by Andre Norton

1. The Proprietors hereby grant to the Publishers the licence to produce and publish the said work in a magazine-edition in the German language.
2. The Publishers hereby agree to publish the said work at their own expense within 12 (twelve) months of the date of this agreement.
3. The Proprietors hereby warrant the Publishers that they have the right to enter into this agreement and that the said work is an original work and in no way whatever an infringement of an existing copyright.
4. The Publishers shall pay to the Proprietors on signing this agreement, the sum of\*\$200.00 (in U.S. currency) in full settlement for the licence to print a magazine-edition as stipulated under clause 1 of this agreement.
5. On Publication date of the work, the Publishers will send six (6) free copies of the translation to the Proprietors.
6. Should the Publishers at any time by themselves or anyone acting on their behalf willfully fail to comply with any of the conditions accepted by the Publishers within three months of being called upon in writing by the Proprietors to remedy such default, the Proprietors may forth with by notice in writing to the Publishers terminate this agreement.
7. The rights conveyed in this agreement to the Publishers shall automatically revert to the Proprietors when the said edition has been sold or after the expiration of ~~twelve (12)~~ years from the date of this agreement..

8. It is expressly understood and agreed that this licence carries with it no further rights or privileges and that all rights not specifically granted herein are reserved exclusively by the Proprietors.
9. The Publishers agree that the translation of the said work shall be made faithfully and undertake that the name of the author shall appear in due prominence on the title page, and that the title of the said work in English shall appear beneath the German title on every copy issued in the language, and all proper steps to secure and protect copy right shall be taken by the Publishers who will also credit their publishing arrangement with ACE BOOKS INC. in every copy of this German Magazine-edition.
