Please note that this grant of rights only covers the use of your story in the anthology as a whole; the right to the story itself (including first and second serial, dramatic, audio, and electronic) remain with you.

This is a very special book for us, and we would very much like for you to be a part of it.


The book is scheduled to be published in by DAW BOOKS INC.
